- 3) Those who pass the 1st audition will be notified by <u>Friday, July 24th, 2026</u>, and will be eligible to take the 2nd audition.

- 5) Submitted documents (résumé and letter of recommendation) are non-returnable.
 - * After the screening and auditions, submitted documents by all applicants except those of a successful applicant shall be shredded and disposed with caution.

The NHK Symphony Orchestra (Public Interest Incorporated Foundation) will properly handle personal information entrusted to us during the recruitment screening process as follows based on Japanese laws and regulations.

1. Purpose of use:

Personal information entrusted to us will be used for the purpose of receiving and keeping record of your application, and contacting you regarding the notification of screening and hiring results. In the case you are hired, we will use it for the purpose of employment and personnel labor management. Unless otherwise specified, we will acquire only the minimum necessary items for business. Submitting personal information is voluntary, but we would like to have your understanding that it may affect the screening process.

Personal information additionally received during the recruiting process is also subject to the same treatment stated above.

2. Provision of information to third parties

Except as stipulated by law, we will provide none of your personal information whatsoever to third parties without your consent.
